The buyer acknowledges that it has not relied on any statement, promise or representation made or given by or on behalf of Leg Avenue which is not set out in any contract with Leg Avenue. Nothing in this condition shall exclude or limit Leg Avenue's liability for fraudulent misrepresentation. Any contract made between the buyer and Leg Avenue shall be on these Conditions to the exclusion of all other terms and conditions (including any terms or conditions which the buyer purports to apply under any purchase order, confirmation of order, specification or other document).

2. Each order or acceptance of a quotation for Goods by the buyer from Leg Avenue shall be deemed to be an offer by the buyer to buy Goods subject to these Conditions. No order placed by the buyer shall be deemed to be accepted by Leg Avenue until a written acknowledgement of order is issued by Leg Avenue or (if earlier) Leg Avenue delivers the Goods to the buyer.
3. The quantity and description of the Goods shall be as set out in Leg Avenue's quotation or acknowledgement of order.
4. There is no minimum order. All items with a unit price of £5.50 and under are pre-packed in six pairs per colour per item. When ordering, the buyer must state this in packs, i.e. 1 pack or 6 when ordering via the website operated by Leg Avenue (the "Website"). The quantity of any consignment of Goods as recorded by Leg Avenue on despatch from Leg Avenue's place of business shall be conclusive evidence of the quantity received by the buyer on delivery unless the buyer can provide conclusive evidence proving the contrary. Leg Avenue shall not be liable for any non-delivery of Goods (even if caused by the Leg Avenue's negligence) unless the buyer gives written notice to Leg Avenue of the non-delivery within seven days of the date when the Goods would in the ordinary course of events have been received. Any liability of Leg Avenue for non-delivery of the Goods shall be limited to replacing the Goods within a reasonable time or issuing a credit note against any invoice raised for such Goods.
5. Unless otherwise agreed by Leg Avenue in writing, the price for the Goods shall be the price set out in Leg Avenue's price list published on the date of delivery or deemed delivery. All prices for Goods (whether sold directly or from the Website) are subject to VAT at the applicable rate from time to time. Costs for postage are set out below.
6. All processed orders must be paid for in full by credit card, BACS or PayPal. Time for payment shall be of the essence.
7. Leg Avenue does not guarantee any sales of Goods. Leg Avenue shall accept no liability for claims in respect of Goods that have been used. All sales are final and no exchanges of Goods or refunds will be allowed. Any requests for exchange of or claims for damage to any sequined or beaded garments must be made within 7 days of the invoice date. All claims for discrepancies in or damage to Goods ordered must be made within 7 days of the invoice date. Leg Avenue will not accept any returns without a prior written authorisation from Leg Avenue's returns department. Any unauthorised returns will result in a 15% restocking fee, the charge for which will be added to the buyer's next order. Leg Avenue shall not be liable for any direct, indirect or consequential loss (all three of which terms include, without limitation, pure economic loss, loss of profits, loss of business, depletion of goodwill and similar loss), costs, damages, charges or expenses caused directly or indirectly by any delay in the delivery of the Goods (even if caused by Leg Avenue's negligence), nor shall any delay entitle the buyer to terminate or rescind any contract.
8. Leg Avenue reserves the right to change its prices and specifications at any time without prior notice.
9. All orders placed before 2pm shall be shipped on the next working day, subject to availability. Any dates specified by Leg Avenue for delivery of the Goods are intended to be an estimate and time for delivery shall not be made of the essence by notice.
10. Any Goods not in stock will automatically be added to Leg Avenue's back order system. The buyer must clearly notify Leg Avenue in writing with each order if it wishes to opt out of this service.
11. Goods on back order will be ordered from the manufacturer every 2 weeks. Back orders will remain on order unless the buyer notifies Leg Avenue by email that it wishes to cancel these.

 - d. for fraud or fraudulent misrepresentation.
15. Leg Avenue reserves the right to defer the date of delivery or to cancel any contract or reduce the volume of the Goods ordered by the buyer (without liability to the buyer) if it is prevented from or delayed in the carrying on of its business due to circumstances beyond the reasonable control of Leg Avenue.
16. Failure or delay by Leg Avenue in enforcing or partially enforcing any provision of any contract or these Conditions shall not be construed as a waiver of any of its rights under any contract or these Conditions.
17. The parties to any contract do not intend that any term of any contract shall be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person that is not a party to it.
18. The formation, existence, construction, performance, validity and all aspects of any contract and these Conditions shall be governed by English law and the parties submit to the exclusive jurisdiction of the English courts.
